1. Pull rods and pump. Remove wellhead, install BOP. Kill well.
2. Release tubing anchor. POH with 2-7/8" tubing and anchor.
3. Set bridge plug. Pressure test casing to 2000 psi.
4. Perforate @ ± 1700 w/4 shots. Set cement retainer.
5. Circulate fluid through production/intermediate annulus to remove drilling mud.
6. Circulate 300 sax Class "C" cement with 2% CaCl_2 through annulus. Close valve and squeeze to 500 psi.
7. Drill out retainer and cement. Retrieve bridge plug.
8. GIH with production equipment.
9. Place well on production.
