35 sx plug at top of salt from 1195 to 1295'

35 sx plug @ base of surface pipe @ 493-393'.

10 sx plug in top of surface pipe with appropriate marker.

Mud will be placed in hole between plugs.

We are waiting for recommendations concerning final clean up and requirements so this  
location can pass inspection for final approval.
