6/23/73 Set bridge plug at 4030, failed to hold. Set second bridge plug at 4024 and perforated 3921, 3922, 3926, 3927, 3931, 3948, 3950, 3982, 3984, 3986, 3988, one hole per interval. Swabbed 3 bbls water per hour, no shows.

6/27/73 Set bridge plug at 3390 and perforated 3126, 3128, 3130, 3134, 3136, 3215, 3217, 3219, 3221, 3223 with one hole per interval. Treated with 1,000 gal 15% HC acid. Swabbed dry, no shows.

6/28/73 Well temporarily abandoned, pending possible use as water disposal well.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
