Blowout preventers will be installed prior to drilling out of surface casing and tested in accordance with State regulations. Drilling of the well will be in accordance with State rules and regulations.

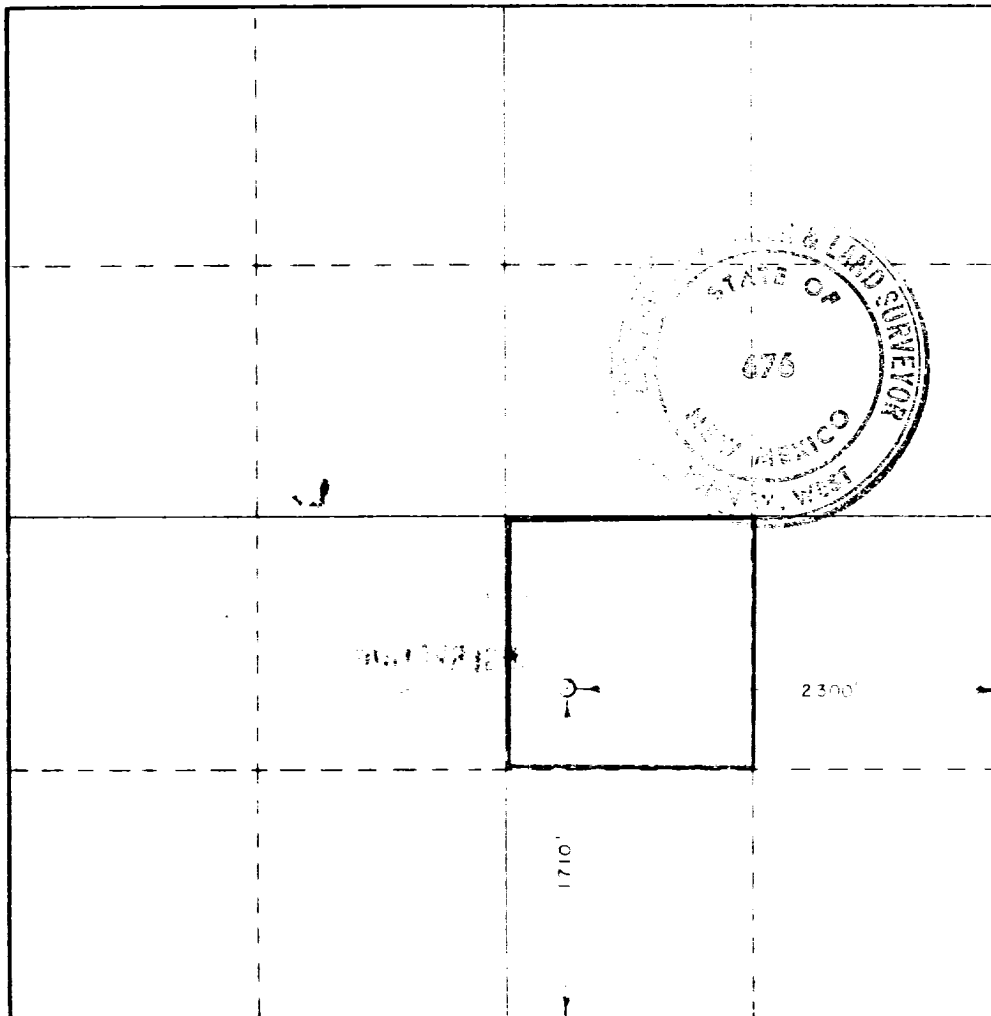
