Moved in service unit 2-2-84. Pulled tubing and packer. Set a cast iron bridge plug at 13200' and capped with 35' cement. Ran Vann guns, 3-3/8" casing gun, and 5-1/2" packer. Spotted guns across Strawn interval 12376'-12384' and correlated on depth. Tested casing to 500 psi and OK. Ran swab. Dropped bar and perforated Strawn 12376'-12384'. Moved out service unit 2-10-84. Ran BHP bomb and left well shut-in. Pulled bomb 2-11-84. Left well shut-in for repair of pipeline. Completed pipeline repair and started flow testing 2-16-84. Ran 4-point test. Flow tested for 74 hours and shut-in well for 72 hours. BHP build-up test. Pulled bomb and returned well to sales. Flow tested for 4 days. Last 24 hours flowed 131 BC, 0 BW and 467 MCFD. Well was successfully recompleted from the Morrow to the Strawn on 2-29-84. Currently producing.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
