Ran 8 jts. 13 3/8" 8rd STC K-55 54.5# casing and set at 330.64'. Cemented with 350 sacks
Class C w/2% calcium chloride and 1/4# flocele per sack. Tested to 600 psi. Held OK.
Plug down at 9:28 A.M., June 5, 1980. Circulated 75 sacks to surface. WOC 18 hrs. NU
BOP's and picked up bottom hole assembly. Prep to start drilling ahead.
