Mr. Glass said to cut csg 75' below stub & 75' up in 8-5/8" csg. Cut csg at 5154'. Had blow on backside. Removed csg slips and installed csg slips. Pulled out of hole w/125 jts of 5-1/2" csg.
- 7-21-99 Spotted 70 sxs "C" cmt plug f/5110'-4912'. Wait on cmt. Tagged cmt plug at 5150'. Andy Cortez w/BLM on location. Pumped another 70 sxs "C" cmt. Wait on cmt. Tagged cmt plug at 4948'.
- 7-22-99 Pumped 35 sxs "C" cmt plug f/2805'-2670'. Pumped 30 sxs "C" cmt plug f/428'-312'. Pumped 20 sxs "C" cmt plug f/50'-surface. Well Plugged and Abandoned.
