- (2) Perforate Zone II, 4174-80, 4686-88, 4194-96'. Zone IIIu, 4222-27, 4229-31, 4248-50, 4262-64' and acidize w/4200 gals 15% HCL-HEA.
- (3) Run 5 1/2" Guiberson Uni-Packer VI, XL on/off tool, and 1.78" profile nipple on 2 7/8" Duoline HT tbg. Displace annulus w/packer fluid. Set packer  $\pm$  4080'.
- (4) Take injectivity test and complete.
