After non-commercial test of the Upper and Main Zones of the Upper Queen during the period from September, 1999 to June, 2001, all Upper Queen perforations have been squeezed with cement, all cement and bridge plugs have been drilled out, and the well returned to production in the Penrose (Lower Queen) sand.

Production from this well with the Penrose (Lower Queen) sand only open is 2-3 BOPD, 2 BWPD with no test on gas production.
