Moved in service unit 10-14-83. Removed tree and installed blowout preventer. Pulled packer and tubing. Ran 2-3/8" seating nipple, 2 joints 2-3/8" tubing, 5-1/2" tubing anchor, and 2-3/8" tubing. Seating nipple landed at 7440' and anchor set at 7376'. Loaded and tested pump to 500 psi. Tested okay. Moved out service unit 10-18-83. Completed re-building wellhead and tied-in flowline. Unable to start gas engine. Repaired engine and started pump test 10-20-83. Pump tested for 6 days and moved in service unit 10-28-83. Changed pump and moved out service unit 10-29-83. Pump tested for 18 days and last 24 hours pumped 0 BO, 30 BW, and 0 MCFD. Shut-in 12-6-83 for fluid build-up and evaluation.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
