Rigged up hot oil truck and hot watered well with 75 bbls 2% KCl FW with 25 gallons wellaid 303C. Pump tested 7 days, last 24 hrs pumped 34 BO, 4 BW, and 30 mcf. Rigged up pump truck 2-15-85 and pumped via csg 200 gals 15% HCl acid and 800 gals Super A-Sol. Flushed with 1500 gals produced water. Began pump testing 2-17-85. Pump tested apx 5 days, last 24 hrs pumped 33 BO, 2 BW, and 32 mcf. Returned well to production 2-22-85.
