Ran and set 52 Jts (2173.40') 8-5/8" OD 24# and 22 Jts (965.60') 8-5/8" OD 32# casing @ 3150' and cemented w/1000 sacks of TLW w/15# salt, 5# gilsonite & 0.25# flocele/sack + 300 sacks of Class C neat cement. PD @ 1812 CST on 11-17-84. Circulated 300 sacks of cement to the surface. WOC 18 hrs. RU BOP's, set slips, CO casing and NU BOP's. Tested 8-5/8" OD casing to 1500# for 30 min. - OK.
