This well is currently uneconomical to produce. Well is being evaluated for possible future beneficial utilization for waterflood performance.

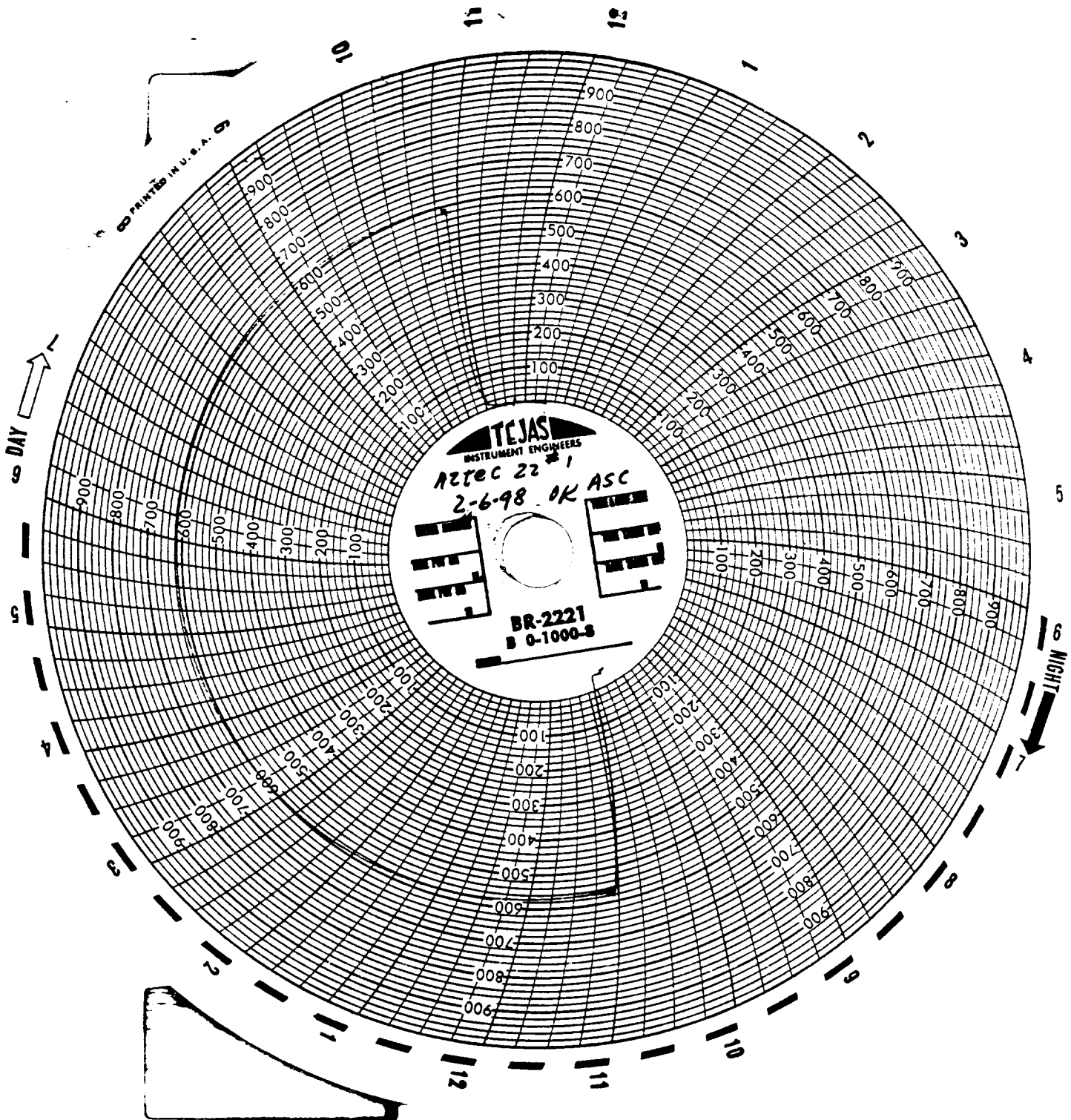
