RIH w/gauge ring to TD - If unable to reach 4275', POOH, PU GR-CCL logging tool & RIH & set on depth w/GR-DEN-Neutron log, obtain GR-CCL log over Queen interval & POOH
Perf 4237'-4245' w/1 jsp (decentralized strip gun)
Acidize new & old perfs using 4000 gals 15% NEFE HCL in 2 stages.
Pump 2500 gal acid, followed w/200# Rock Salt block & then pump remaining 1500 gal 15% NEFE HCL acid.
Monitor treating pressure, not to exceed 4500# surface pressure.
SI for 30 mins, flow well back w/at lease twice the volume from btm perf to surface.
Put well back on injection & obtain inj rate & surface pressures until well stabilizes. Obtain step rate test.
