(377.00') of 8-5/8" OD 24# casing @ 388' and cemented w/350 sacks of Class C + 2% CaCl₂ cement. PD @ 1712 MDT on 9-27-85. Circulated 93 sacks of cement to the surface. WOC 18 hrs. Tested the 8-5/8" OD casing to 600# for 30 min.- OK.
