O.T.D. 9000' Dolomite, PBTD 4277'. It is proposed to plug and abandon this well in the following manner:

1. MIRU a pulling unit and pull rods, ND WH, NU BOP's and POOH w/tubing.
2. RU w/wireline and set a 8-5/8" CIBP @ 4180' and dump 6 sacks of cement on top @ 4180 - 4158', plugging off the Queen Perfs @ 4218 - 4248'.
3. RIH w/OE'd tubing to 4050' and pressure test the casing to 1000# and load the hole w/9.5# mud laden fluid. POOH w/tubing to 1450'.
4. Spot a 30 sack Class C cement plug @ 1450 - 1340', across the top of the salt section. Displace plug w/mud laden fluid. POOH w/tubing to 490'.
5. Spot a 30 sack Class C cement plug @ 490 - 380', 1/2 in and 1/2 out of the 13-3/8" casing shoe @ 450'. POOH w/tubing.
6. Cut of the WH and casing below the GL and spot a 14 sack Class C surface plug @ 52 - surface and install a dry hole marker to designate a plugged and abandoned location.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
