① Set CIBP @ 9309'

③ Set Cement Retainer @ 7175'

④ Circulate cement (outside 5 1/2" casing) from 7235' (hole in seq.)
to 3008' (will try to tie cement back into 8 5/8" intermediate).

⑤ Perforate Delaware; acidize &/or frac; put on pump.

GENERAL: This form is designed for submitting proposals to perform certain well operations, as indicated, on all types of lands and leases for appropriate action by either a Federal agency, or both, pursuant to applicable Federal and/or State laws and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

ITEM 1: If the proposal is to re-drill to the same reservoir at a different subsurface location or to a new reservoir, use the form with appropriate notations. Consult applicable State or Federal regulations concerning subsequent work proposals or reports on the well.
