On April 9, 2002, the Roswell office of the Bureau of Land Management approved the re-compleat of Mescalero Ridge Federal Well No. 2, a temporarily abandoned well in the Mescalero Escarpe:Bone Spring Field. The re-compleat zone will be the Queen sand.

The acreage on which the referenced well is located is within the boundaries of the E-K Queen Unit, an existing Queen sand waterflood located in the E-K:Yates Seven Rivers Queen Field.

This Notice of Intent is filed to propose the changing of the lease name, well number and field designation for this well to E-K Queen Unit Well No. 210, E-K:Yates Seven Rivers Queen Field, Lea County, New Mexico.
