T.D. 4352' Anhydrite & Dolomite, PBTD 4165'. Temporarily abandoned. MIRU a completion unit and CO to 4308'. Perforated the Queen Formation w/4 SPF @ 4275, 77, 83, 84, 85, 86, 89, 90, and 4291'. Total of 36 holes (0.45" dia & 14.7" pen in Berea Sand). RIH w/5-1/2" packer on 2-7/8" tubing and set the packer @ 4163'. Acidized thru Queen Perfs @ 4275 - 4291' w/1900 gals of 7-1/2% NeFe HCl acid. Max press 3500#, min press 2400#, ATP 2500#, AIR 4.3 BPM, ISIP 2020#, 5 min SIP 1180#, 10 min SIP 900#, 15 min SIP 620#. 10 hr. SITP 0#. Swabbed -0- BO + 33 BLW/7 hrs. and swabbed dry. Fraced thru Queen Perfs @ 4275 - 4291' w/19,500 gals crosslinked gelled 2% KCL water w/5% diesel (40# sys.) + 6,000# 20/40 sand + 31,100# 12/20 sand. Max press 4970#, min press 4250#, ATP 4500#, AIR 22.0 BPM, ISIP 2450#, 5 min SIP 2350#, 10 min SIP 2350#, 15 min SIP 2350#. 14 hr. SITP 0#. Swabbed -0- BO + 121 BLW/ 11 hrs. POOH w/packer and tubing. RIH w/2-3/8" tubing and set the tubing @ 4282'. RIH w/BHP and rods and put the well on the pump. Pumped 1 BO + 154 BW/24 hrs. POOH w/BHP, rods, and tubing. Set a 5-1/2" CIBP @ 4200' and dumped 4 sacks of cement on top @ 4200 - 4165'. RIH w/2-3/8" tubing and loaded the hole w/150 barrels of packer (Unichem) fluid. POOH w/ tubing and ND BOP and NU WH and temporarily abandoned the well.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
