O.T.D. 4350' Anhydrite. This well was originally drilled to a T.D. of 4350' in Anhydrite and plugged and abandoned as a dry hole on 12-28-86. It is proposed to re-enter this well and complete in the Queen Formation in the following manner:

1. MIRU a completion unit with a reverse unit and RIH w/7-7/8" RB, 4-3/4" DC's on 2-7/8" tubing and DO cement plugs @ the surface - 55', 323 - 423', 1522 - 1622', 2816 - 2916' and 4150 - 4350' (T.D.) and circulated the hole w/10# BW. POOH w/RB, DC's and tubing.
2. RU casing crew and run and set 5-1/2" OD 14# K-55 casing @ 4350' and cement w/1200 sacks of HOWCO Lite w/15# salt + 0.25# Flocele/sack + 200 sacks of Class C + 2% CaCl₂ cement. Circulate the cement to the surface. ND BOP, set slips, CO casing and WOC for 24 hrs.
3. NU WH, NU BOP and RIH w/4-3/4" RB & 5-1/2" csg. scraper on 2-7/8" tubing and DO to PSTD. POOH w/RB, csg. scraper and tubing. (CONTINUED ON ATTACHED SHEET)

INSTRUCTIONS

GENERAL: This form is designed for submitting proposals to perform certain well operations, as indicated, on all types of lands and leases for appropriate action by either a Federal or a State agency, or both, pursuant to applicable Federal and/or State laws and regulations.
