T.D. 4350' Anhydrite. Plugged and abandoned. Drilled a 7-7/8" hole from a T.D. of 374' to a T.D. of 4350' in Anhydrite and after receiving verbal BLM approval, from Mr. Amando Lopez with the Roswell Office, this well was plugged and abandoned in the following manner:

1. RIH w/OE DP to T.D. 4350' and loaded the hole w/10.2# mud laden fluid.
2. Set a 50 sack cement plug @ 4350 - 4150', across the top of the Queen Formation. POOH to 2916'.
3. Set a 25 sack cement plug @ 2916 - 2816', at the base of the salt. POOH to 1622'.
4. Set a 25 sack cement plug @ 1622 - 1522', at the top of the salt. POOH to 423'.
5. Set a 25 sack cement plug @ 423 - 323', 1/2 in and 1/2 out of the 8-5/8" casing shoe @ 373'. POOH to 55'.
6. Set a 15 sack cement surface plug @ 55 - surface and installed a 4" dry hole marker to designate a plugged and abandoned location.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
