Operator wishes to convert the subject well to water injection as part of waterflood operations for a proposed Querecho Plains Bone Spring Sand Unit. This unit is currently being applied for with the New Mexico Oil Conservation Division. Injection will be through currently open perforations with a packer set within 100' of the top perf. An inert fluid will be placed in the tubing-casing annulus. The water to be injected will be produced water from the Bone Spring, Delaware and/or Queen formations. If additional volumes of water are required, the City of Carlsbad will be approached for a tap on their Caprock System. Work will begin upon receipt of the state's Division Orders.
