Spotted 40 sacks cement 10990-11300' and abandoned Pennsylvanian zone.

Perforated 5-1/2" casing, Wolfcamp zone, 10878-10884' and 10888-10894'. Swab-tested non-productive. Set cast iron bridge plug at 10780'. Dumped 1 sack cement on top of plug; checked top of cement at 10772'. Perforated 5-1/2" casing, Wolfcamp zone, 10662-10672'. Acidized and swab tested; 100% salt water.

Spotted 50 sacks cement 10590-10190', filled hole with mud, spotted 50 sacks cement 6700-6300' and abandoned Wolfcamp zone.

Perforated 5-1/2" casing, Glorieta zone, 6164-94' and 6226-36'. Swabbed 100% sulphur water.

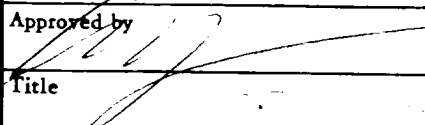
