It is proposed to perform a casing integrity test on the well in preparation for requesting temporary abandonment approval. The following procedure will be followed:

1. POOH with production equipment.
2. Set a plug within 100' of the top perf.
3. Notify the BLM 24 hours before pressure testing casing to 500 psi for 30 minutes.
4. RIH with tubing and circulate packer fluid.
5. POOH with tubing and fill hole with packer fluid.

When completed, a successful pressure test will be submitted with a reason and a request to temporarily abandon this well for another year.
