2-18-92. Drilled out DV tool @ 4527'. Perforated 5210-7533' w/84 - .42" holes (2 SPF) and treated as follows:

Zone 1) 7514, 17, 22, 24, 28, 33 (12 holes). Acidized w/750g. 7½% NEFE. Frac w/2000g. linear pad, 9500g. XL gel + 24000# 20/40 sand.

Zone 2) 6653, 54, 55, 59, 60 (10 holes). Acidized w/500g. 7½% NEFE. Frac w/1500g. linear pad, 7125 g. XL gel + 18000# 20/40 sand.

Zone 3) 6387, 90, 97, 6400, 13, 16, 24, 25 (16 holes). Acidized w/1000g. 7½% NEFE. Frac'd w/2000g. linear pad, 14000g. XL gel + 36000# 20/40 sand.

Zone 4) 6246, 47, 55, 73, 74, 92, 94 and 6301' (16 holes). Pumped into perfs @ Zone #4 - had communicated to Zone #3.

Zone 5) 6156, 62, 63, 68, 69 (10 holes). Acidized w/500g. 7½% NEFE. Frac'd w/1500g. linear pad, 7125 g. XL gel + 18000# 20/40 sand.

Zone 6) 5554, 55, 56, 57, 58 (10 holes). Acidized w/500g. 7½% NEFE.

Zone 7) 5210, 16, 18, 20, 24 (10 holes). Acidized w/500g. 7½% NEFE. Frac'd w/2000g. linear pad, 9500g. XL gel + 24000# 20/40 sand.
