An area wide geologic and engineering review of the Bone Spring formation is currently in progress. At the conclusion of this study, if economic conditions permit, this well will be recompleted in the 2nd Bone Spring Sand. If recompletion cannot be economically justified, it is planned to plug and abandon the well. It is anticipated that the study will require 3 to 6 months to complete, and another 3 to 6 months to execute the recompletion program. It is respectfully requested that a Temporarily Abandoned status be granted to this well for 1 year.
