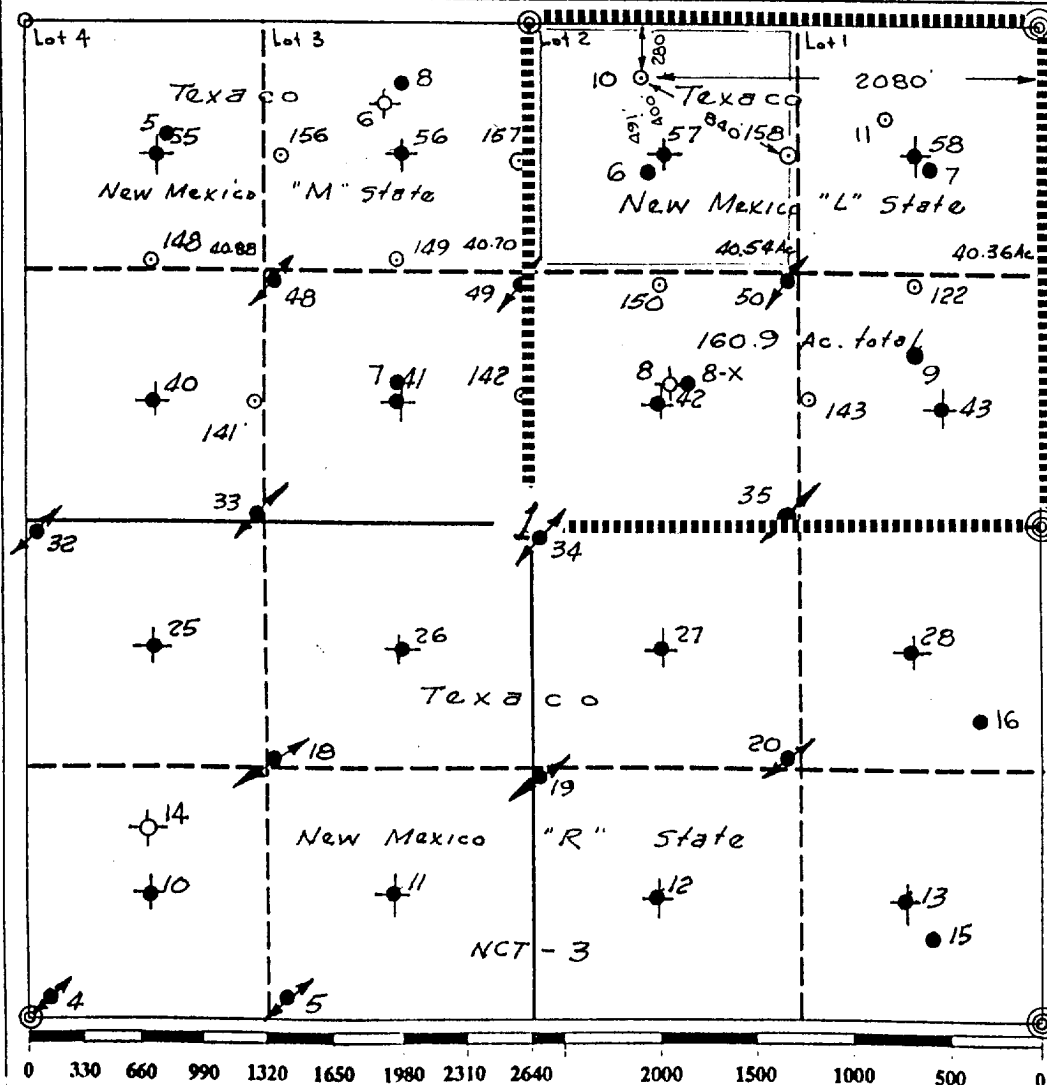

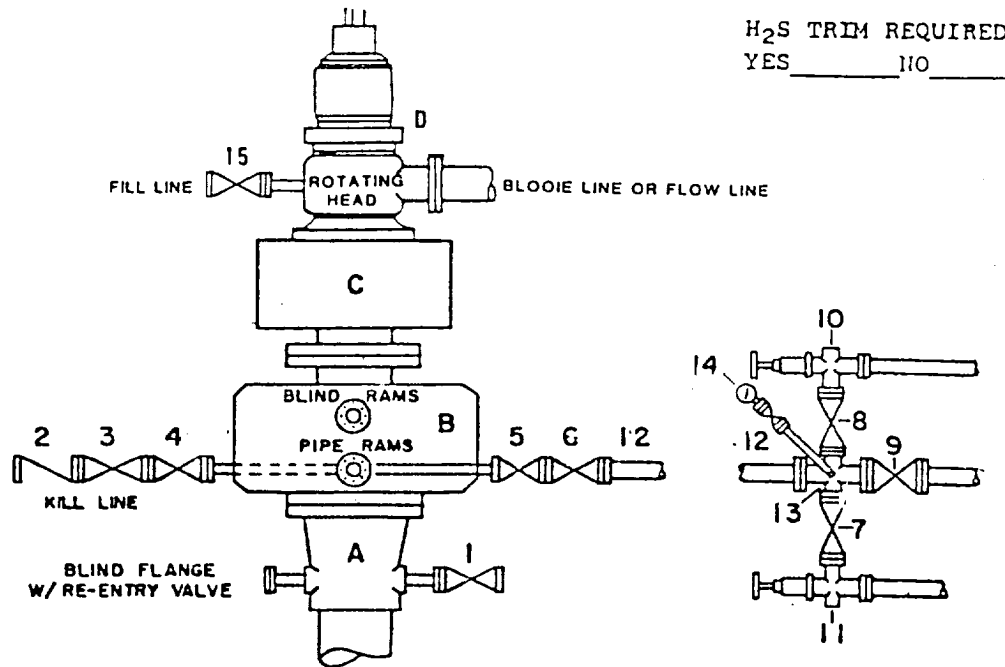

Gentlemen:

An Exception, by administrative approval, to Rule 104, C. I. is requested for Texaco Producing Inc.'s New Mexico "L" State Well No. 10. This well is located 280' FNL & 2080' FEL, Unit Letter "B", of Section 1, T-18-S, R-34-E.

This well could not be staked in a regular location because of a "paved road". The location was moved 50' North to avoid this road.

The only "affected" offset operator is Texaco Producing Inc. and we grant ourselves a waiver to the Non-Standard location. Attached is a copy of the Form C-102 and a lease plat showing the location of the subject well.
