

Plan to add additional perforations from 3515' - 3528' and acidize w/ 500 gallons of 7.5% acid. Will frac all perforations 3412' - 3422'; 3468 - 3478' and 3515' - 3528' with 100,000# of 20/40 and 12/20 sand. Frac job may be altered when job design is completed. Return well to production in Buffalo Yates.
