11-12-99 MIRU. Pumped 52 bbls 2% KCL water containing 30 sacks 20/40 sand.
11-15-99 Tagged top of sand at 12,878'. Dumped 20 sacks of cement on top of sand, 12,878' to 12,858'.
11-16-99 Perf'd Strawn zone with 4 SPF f/11968'-11986', 12,136'-12,144', 12,210'-12,240', total 224 holes. New PBTD is 12,858'.
11-19-99 Spot 15 gls of 15% NEFE acid across perfs.
11-22-99 Moved off location. Perf's are not breaking down. Appears that perfs did not penetrate the casing. Well is currently Shut-in waiting on special perforating tool.
12-8-99 Ordered special perforating tool. Waiting on equipment to arrive to continue this workover. A second sundry will be submitted when we continue this workover. This sundry is being submitted so that you will know the status of this workover.
