Request for Temporary Abandonment on Federal Lands Cochise "1" Federal #1 Unit E, Section 1, T19S, R32E 1650' FNL & 990' FWL

Mitchell Energy Corporation requests an approved Temporarily Abandoned status based on the following:

- 1. The appropriate BLM office was notified at least 24 hours prior to the casing integrity test. The test was witnessed by Mr. Steve Caffey on January 13, 1995.
- 2. Perforations 7472'-7500' were isolated by a CIBP (capped with 35' of cement) set at 7450'. This plug is within 50' above the perforated interval.
- 3. All downhole production equipment has been removed from the well.
- 4. The casing was filled with 2% KCL water containing oxygen scavenger. Casing was tested to 600 psi for 30 minutes being witnessed by Mr. Steve Caffey.

The subject well is ideally located for use as a water supply well for a proposed Yates waterflood. Attached map shows a rough outline of the project. Contacting of involved operators has just begun, the earliest any actual operations could start is the first quarter of 1996.
