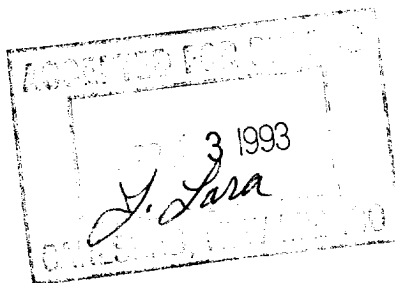

2-15-93 Frac 8,833'-8,930' w/29,500 gals YF135 gel + 100,000# 20/40 Ottawa sand + 20,000# 20/40 resin-coat sand.

2-16-93 Placed 8,833'-8,930' on pump for production test before opening additional pay.

3-12-93 MIRU to continue recompletion.

3-15-93 POOH, set RBP @ 8,720', & test RBP to 3000 psi. Perf 1 SP2F, 8,598'-8,620' (12 holes) & 8,633'-45' (7 holes).

3-16-93 Acidize 8,598'-8,645' w/2000 gals 15% NEFe acid.

3-17-93 Frac 8,598'-8,645' w/39,000 gals YF135 gel + 122,000# 20/40 Ottawa sand + 28,000# resin-coat sand. Pull RBP.

3-19-93 Place 8,598'-8,620' & 8,833'-8,930' on production with EOT @ 8,981', SN @ 8,917', & TA @ 8,504'. 2 7/8" prod tbg w/76 rod string & 25-150-RHBC-26-5 pump. 10 x 144" SPM.
