WELL CURRENTLY COMPLETED AS AN INJECTION WELL IN THE VACUUM DRINKARD POOL WITH PERFS FROM 7585'-7829'. THE FOLLOWING PROCEDURE IS TO PLUGBACK THE WELL INTO THE VACUUM BLINEBRY AS A PRODUCING OIL WELL

1. MIRU. Install BOP & TOH w/ injection tbg & pkr. RIH w/ bit & scraper. Clean out 5-1/2" prod csg to 7550'.
2. TIH w/ 5-1/2" CIBP & set @ 7535'. Cap CIBP w/ 35' cement (New PBTD: 7500').
3. Perforate Vacuum Blinebry from 6664' - 6848' (2 jsf, 94 hles, 120° phasing, .45" holes, 4" gun)
4. TIH w/ 5-1/2" treating pkr & RBP on 2-7/8" WS. Pressure test tbg to 8,000 psi going in hole. Set RBP @ 6898' & pressure test. Set pkr @ 6634'. Load BS w/ 2% KCL water & test to 500 psi.
5. Acidize Vacuum Blinebry perfs (6664'-6848') with 2,500 gallons 15% NEFE HCL. Acid fracture perfs w/ 12,000 gallons 20% HCL.
6. Flow well back immediately until dead. Swab out residue. TOH with WS, pkr, & RBP.
7. TIH with production equipment. Set seating nipple @ ~ 7050'. Return well to production as a oil producer in Vacuum Blinebry pool.




