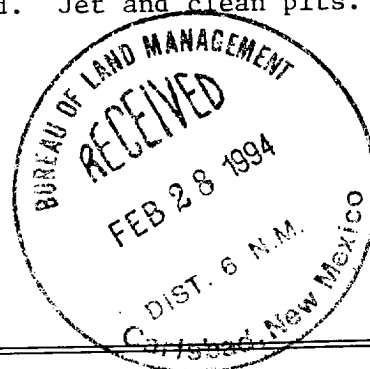

2/23/94: Cemented 1st stage w/ 850 sx "H" containing .8% FL-25 and 5% A-5. Plug down at 1:30 a.m. MST. Open stage tool and circ'd 189 sx to pit. Cemented 2nd stage w/ 815 sx "C" Lite. Tail w/ 400 sx C1 "C". Plug down at 9:45 a.m. ND, set slips, cut off 5-1/2" casing. NU tubing head. Jet and clean pits. Released rig at 3:00 p.m. MST. WOCU.
