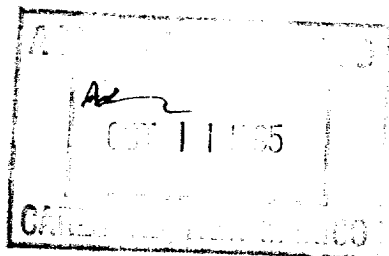

Proposed plan is to drill 7-7/8" hole to 5500', run 5500' of 5-1/2" J-55, 15.5# ST&C casing. Cement with 450 sxs, Prem Plus. .4% Fluid loss. 2% gel, 10 pps micro bond. Bring cement top to the base of salt and above the Yates @ ± 2650'. Verify top of cement with cement bond log.

As per Shannon Shaw, review indicates that numerous wells have been completed in an analogous manner. Some wells have been producing since about 1960 w/o severe corrosive damage.
