

## CORRECTED COMMINGLING ORDER PLC-103

The above-named company is hereby authorized to commingle Vacuum Abo Reef (61780), Vacuum Drinkard (62110) and Vacuum Atoka (96454) Pool production from the following leases:

Lease: NM 'R' State NCT-1 Well No.6 Description: SE/4 NE/4 of Section 6, and Lease: NM 'AB' State Well Nos.2, 3, 4 and 9 Description: E/2 SE/4, SW/4 SE/4 of Section 6, and Lease: NM 'AN' State Well Nos.1, 2, 3, 4, 5, 6 and 7 Description: NE/4, N/2 SE/4 and SW/4 SE/4 of Section 7;

Lease: Hobbs 'N' State Well No.5 Description: SE/4 NE/4 of Section 8;

all in Township 18 South, Range 35 East, NMPM, Lea County, New Mexico.

Lease: NM 'AE' State Well Nos.9 and 26 Description: NE/4 NW/4 and SW/4 NW/4 of Section 12, Township 18 South, Range 34 East, NMPM, Lea County New Mexico.

Production shall be allocated to each lease by well tests. (If this method is to be authorized, all commingled production must be of identical ownership including working interest, royalty interest, and overriding royalty interest.)

FURTHER: The operator shall notify the Hobbs District Office of the Division upon implementation of the commingling process.

NOTE: This installation shall be installed and operated in accordance with the applicable provisions of Rule 309-B of the Division Rules and Regulations and the Division "Manual for the Installation and Operation of Commingling Facilities."
