The Oil Conservation Division has assigned API # to the two wells as follows:

Lusk Deep Unit A #23-K, 20-19s-32e -- API #30-025-34173

South California Federal Unit #14-C, 29-19s-32e -- API #30-025-34172

These two well are not listed on the order R-10863 and you cannot inject into these wells. The order has to be amended or another order approved to grant you permission from the Oil Conservation Division to inject into these wells.

If these two wells are to be part of the waterflood, they need C-104 forms sent in to the District I Hobbs office to change the property name to the correct Lusk West Delaware Unit.
