MI x RU pulling unit. NDWH x NUBOP. Pull production equipment. Run cement evaluation log (USI) from 3300'-4362'. RIH with 126 jts. 2-7/8" tubing. NUBOP x NDWH. RD PU x clean location.

3/3/99 - 3/16/99:

RU PU. NDWH x NUBOP x pull 2-7/8" tubing. Pick up x set CICR x establish injection rate (2 BPM @ 70 psi). Mix and pump 100 sx. CL. C Neat x squeeze perfs at 4072'-4106'. Drill out cement retainer x circulate well. RU swabbing equipment x swab well. RIH with packer and pressure test. Pick up and run 96 jts. 2-7/8" tubing x ESP. NUBOP x NDWH. RD PU x clean location.
