6/6/00: **Rm 38 jts. 8-5/8", 24#, J-55, ST&C casing with 10 centralizers and set at 1542'. Cement with 475 sx. PBCZ lead and 225 sx. PBCZ tail. Plug down and circulate 30 sx. to pit (Andy with BLM present). WOC. Cut off casing x weld on wellhead. NU BOP x test blind rams to 1500 psi for 30 minutes. Cut drilling line x pick up BEA x TIH. Test pipe rams to 1500 psi for 30 minutes. Install rotating head & drive bushing x drill out cement.**


