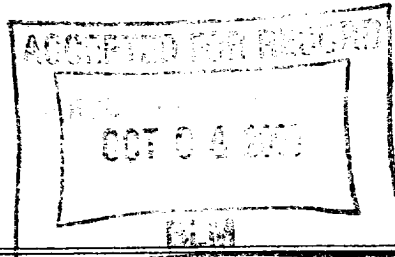

Spudded subject well at 5:00 p.m. MDT on 9/9/00. On 9/12/00 44 joints of 8-5/8" 24#/ft J-55 casing was run to 1723' RKB. Casing was cemented with 375 sxs 35/65 pozmix with 6% salt, 1% CC, and 1/4 lb flocele/sx followed by 125 sxs Class "C" with 2% CC and 1/4 lb flocele/sx. Plug down at 11:30 p.m. MDT on 9/12/00. Tested casing and BOP stack to 1000 PSI prior to drilling out.
