09/19/02 Ran 106 joints of 8 5/8" intermediate casing (3992') - Cemented 1st stage with 200 sxs Class "H", & 350 sxs Class "C". Plug down at 6:15 pm.

09/20/02 Cemented 2nd stage with 250 sxs Class "H" & 1850 sxs Class "C". Circulated 250 sxs to pit. Plug down at 8:00 am. Pressure test to 2000 #.

10/01/02 Ran 182 joints of 5 1/2" production casing (7303') - Cemented with 600 sxs 35:65 with 3% salt, 5/10% FL52, & 550 sxs Poz C with 2% KCL. Circulated 160 sxs to pit. Plug down at 12:00 pm.
