3. Acidize w/1000 gallons. Fracture stimulate w/30,000 gallons & 60,000 lbs. sand.
4. Move RBP to 5600'+/-. POOH w/pkr. & tbg.
5. Perforate from 5482-88 & 5553-57.
6. Acidize w/1000 gallons. Fracture stimulate w/15,000 gals. & 30,000 lbs. sand.
7. POOH w/tools & tbg.
8. Return to production.
