Fracture stimulated with 18,000 gallons gelled KCL and 28,900 lbs of 16/30 sand. POOH with tubing. WIH with perforated sub seating nipple and 135 joints tubing. Perforated sub set @4470'. WIH with 1½" x 16 subsurface pump and rods. Spaced well out. RD and MO CU. Installed pump and equipment. Well not commercial.

Seely Oil Company requests permission to plug back and complete in the Yates Dolomite. Seely will complete and file all completion paperwork as soon as the proposed recompletion in the Yates Dolomite is completed.
