The subject well reached TD of 6050' RKB on 12/22/01. 5 1/2" 17 lb/ft J-55 casing was run to 6042' RKB and cemented with 600 sxs Interfill "C" plus 650 sxs Premium Pozmix with 6 lbs salt per sack and 3/4 of 1% CFRIII. Plug down at 11:15 a.m. MDT. Tested casing to 2500 PSI prior to testing flowback. WOC.
