The surface disturbance will be a clearance of 1,513.2' long x 50' wide will be dragged and a 12" deep ditch dug where the line will be buried. After completion the site will be left in an aesthetically pleasing condition as possible. Archeological Survey Report has been filed and a survey plat is attached.

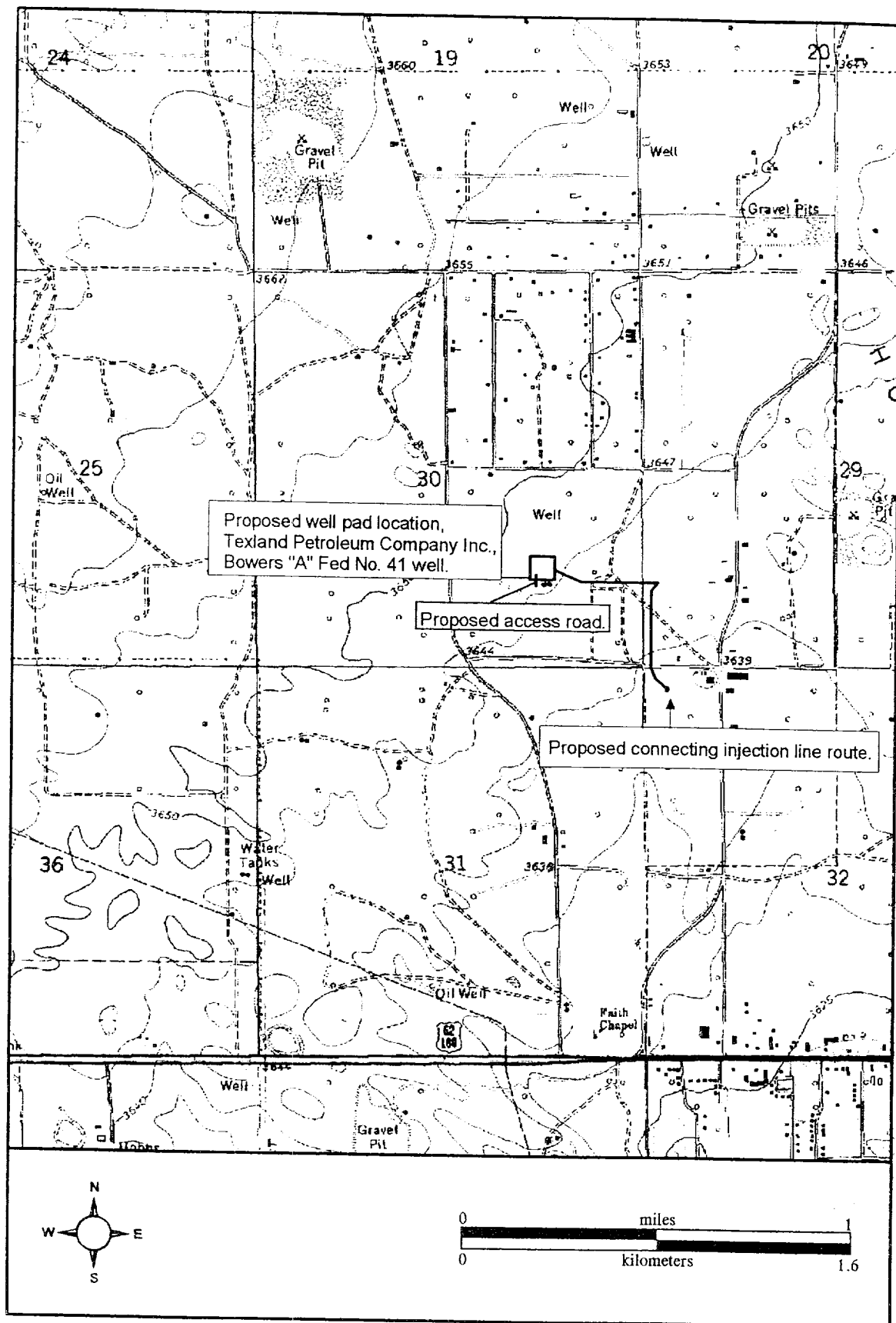
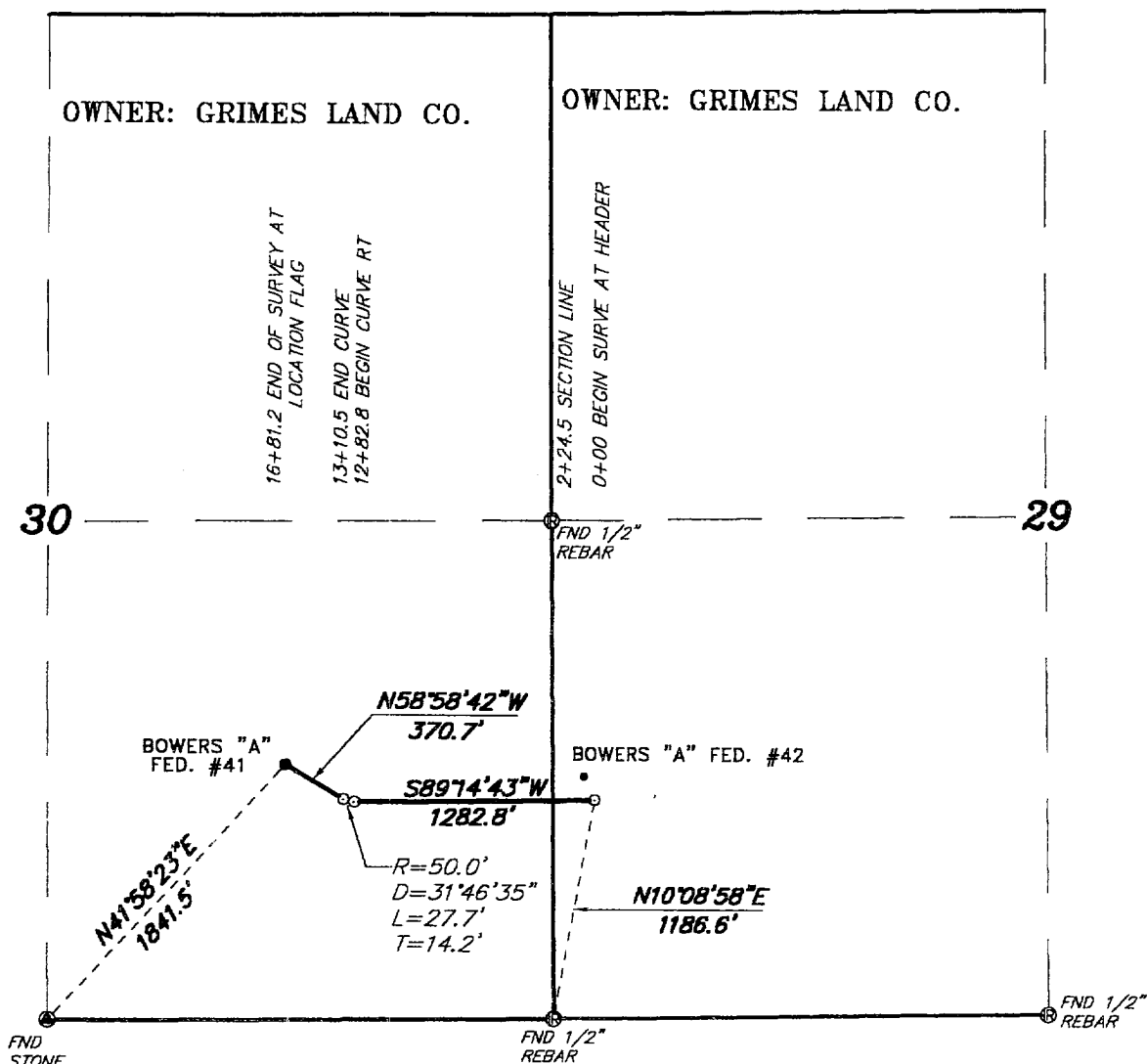


Figure 1. Proposed well pad location, 60 ft of access road, and 3,3194.4 ft of connecting injection lines for Texland Petroleum Company Inc., for the Bowers "A" Fed No. 41 well (USGS 7.5" map, Hobbs West, NM 1979).

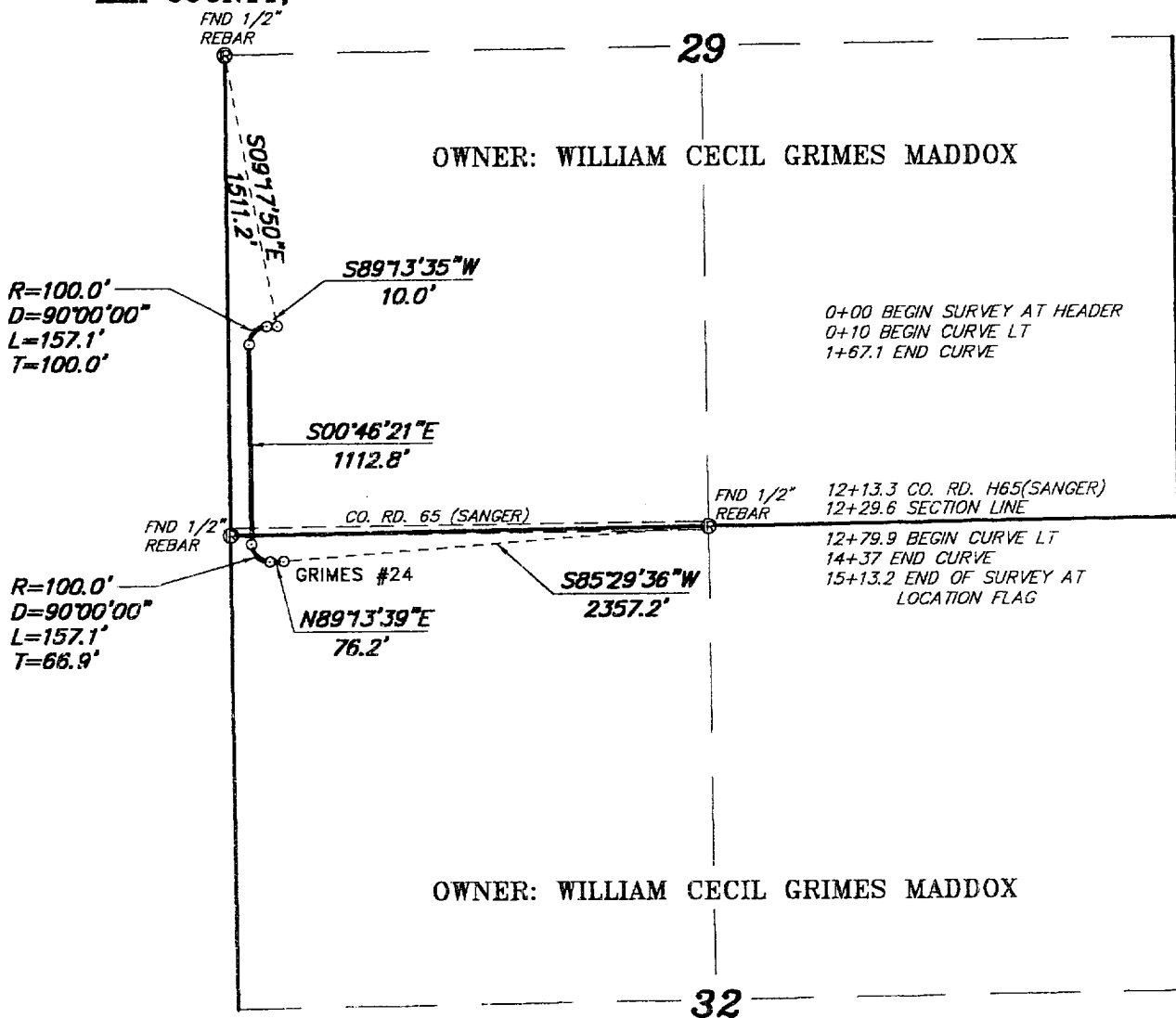
