followed by 200 sxs Class C + 1% CaCl2.
Opened stage collar and circulated out 164 sxs cement.
2nd Stage - Pumped 775 sxs 35:65:6 Poz-C-Gel + 3% NaCl + .25 pps CF
followed by 150 sxs Class C + 1% CaCl2.
Circulated 71 sxs cement to surface.
Tested BOP to 5000 psi.
