Reference is made to your request dated February 7, 2002 to relocate the Bowers "A" Federal Well No. 43, an injection well within the Hobbs Upper Blinbry Cooperative Waterflood Project, from its originally proposed location 1378 feet from the South line and 1155 feet from the West line (Unit L) of Section 29, Township 18 South, Range 38 East, NMPM, to a new location 1243 feet from the South line and 1015 feet from the West line (Unit L) of said Section 29. It is our understanding that the location change is necessary due to surface considerations.

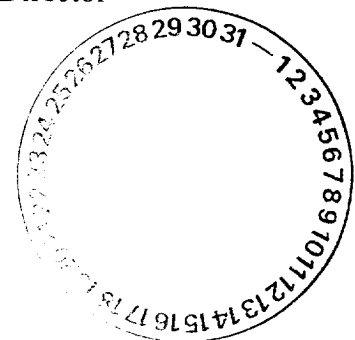
