2. Zones do not appear to be commercially productive. Ms. Alexis Swoboda with the BLM Office in Roswell provided the plugging procedure. Operations began to plug and abandon well. Mr. Marlan Deaton, the BLM representative witnessed the procedure.
3. 5/1/02 and 5/2/02 set cement plugs as follows:
 - 1st plug @ 4383' - 4483' with 40 sxs Class "C".
 - 2nd plug @ 2933' - 3003' with 45 sxs Class "C" with 3% Cac/2 and no tag.
 - 3rd plug @ 2933' - 3003' with 45 sxs Class "C" with 3% Cac/2 and tag @ 2933'.
 - 4th plug @ 1611' - 1767' with 65 sxs Class "C" with 3% Cac/2 and tag at 1611'.
 - 5th plug @ 375' - 500' with 30 sxs Class "C" Neat.
 - 6th plug @ 0' - 60' with 35 sxs Glass "C" Neat.
4. Circulated 13 sxs to pit.
5. Dry hole marker erected.
