

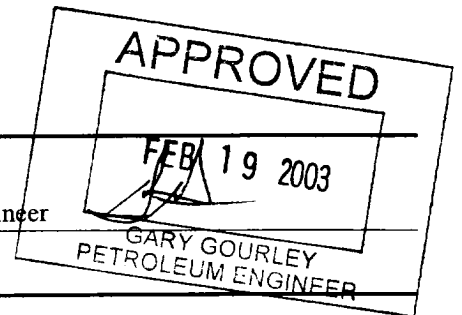


Concho Oil & Gas Corp. respectfully requests permission to change the BOP testing of the Edith Federal #4 as follows:

After setting 8-5/8" csg, install 3000# csg head. NU 11" 5000# double ram BOP & 5000# annular BOP. RU independent tester & test double ram BOP to 3000# & test annular to 1500#.
