DETAILS OF WORK

As per conversation with Mr. Jack Frost set a 20 sack cement plug from 2490 to 2550 leaving 43 feet of cement in 8 5/8" pipe. Set 20 sack cement plug from 1115 to 1155 after recovering 1893 feet of 8 5/8". Then pulled ~~299~~ feet of 10 3/4". 20 sack cement plug placed at the surface and erected customary marker. All intervals between plugs from surface to total depth left full of mud. Weight 0.5. Work done by Denton Oil Well Cementing Co. on July 10, 1951. Abandoned at 6200'. Drill stem test indicated dry hole.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
