...and the fact that the *Journal of the American Medical Association* is the only journal in the field to have a dedicated section for the study of the history of medicine.

Figure 1 is a schematic representation of the experimental design. It shows a sequence of events: a subject is presented with a stimulus (a face), then a response is recorded (a button press), and finally a reward is delivered (a coin). The sequence is repeated for multiple trials.
